The British Energy restructuring

There have been few instructions as challenging as the British Energy restructuring in recent years. Clifford Chance's role advising the energy group put the firm in the eye of the storm.

The Magic Circle firm was brought on board after British Energy found itself in financial difficulties due to falling power prices and high fixed costs. After negotiating an emergency cash facility from the government, Kossoff, Poulton and the CC team were faced with numerous obstacles. They renegotiated British Energy's arrangements with British Nuclear Fuels as well as the group's nuclear liabilities; reached an agreement with the energy group's creditors; successfully resolved the lengthy EU state aid approval process; and completed the disposal of British Energy's Canadian operation, Bruce Power, and its 50% interest in Amergen in the US.

As power prices recovered, two British Energy shareholders, Polygon and Brandes, challenged the original shareholders agreement. In the face of litigation in the US and a circular written by CC, Polygon backed down. The whole restructuring was brought to a close in January 2005 when British Energy's shares relisted on the London Stock Exchange, valuing the company at about £1.5bn.

Kossoff and Poulton received numerous plaudits for leading the team, with antitrust specialist Robin Griffiths drawing particular praise for his advice on the EU state aid process. Again, CC demonstrated that it is one of the few firms that has the resources and experience to handle a deal of such size and complexity.
